Biological diversity and ecosystem services are key concepts for the integrated study of socio-ecological systems. They are also developing into guiding principles for sustainable land management. At the symposium, scientists from Japan and Germany will present research results and ongoing projects that address various aspects of biodiversity and ecosystem services in Satoyama landscapes. Further research needs will be discussed, and funding opportunities to extend Japanese-German exchange and collaboration in this emerging, transdisciplinary research field will be highlighted.
